MINUTES OF THE MEETING OF THE HAVERSHAM CUM LITTLE LINFORD PARISH COUNCIL HELD AT HAVERSHAM SOCIAL CENTRE ON MONDAY 19th DECEMBER 2016 at 8.00pm

1. APOLOGIES

2. PUBLIC FORUM

Mr & Mrs Gilbert wished to make two points about the school expansion consultation. Firstly to reiterate that Haversham Social and Community Centre as partner on the site had never been properly considered or consulted. The proposed changes would have a major impact on the way the Centre operates as the grounds would become too small under the current proposals. This would affect three major annual village events. These events could be moved to the adjacent Recreation Field but the events would suffer from having no water, electricity or toilets. Their second point was that although parking spaces had been increased by 27 there would actually be a pupil increase of a 100. What steps were MKC going to take to cater for this increase in parking and for the traffic congestion? In light of these comments and the recent consultation event at the school – the second being due on 9th January – it was agreed to invite the relevant officer, Glen Oldfield to the next Parish Council meeting. Clerk Philip Ayles, Chair of Castlethorpe Parish Council, informed members as to the options for spending powers for a 'fighting fund' to help defend the interests of the residents of the parish against the possible urbanisation of the area (as proposed in the latest Plan MK document). Currently the only spending power open to the Parish Council was under Section 137; this amounted to £4,903 at the present rate for 2016-17. (see item 7 below)

5.1 Skate Park proposal – the Clerk had circulated via email a report on his disappointing meeting with the Hockey Foundation committee, accompanied by a member of the user group. The Foundation appeared to be insisting on the setting up of a club to operate the venue. It was agreed that the Clerk write thanking the Foundation, explaining that the Parish Council considered this condition unviable.

7. PLANMK

Following the recent release of the proposed PlanMK 'areas of expansion' that included the area north of urban MK and the whole of Haversham cum Little Linford Parish, and following the community meeting that preceded this meeting it was resolved "To respond to the latest development of PlanMK by appointing a planning consultant, and that the power to do this be devolved to two parish councillors in consultation with a representative from Castlethorpe Parish Council and a representative from Protect Rural MK". Proposer Cllr Furniss, seconder Cllr Langham. Unanimous. It was further agreed, following information discussed in Public Forum (above), to commit the vast majority of S137 funding allocation (£4,903) to this contingency.

8. LANDSCAPE CONTRACT RENEWAL

The Clerk had received two updated quotations from the contractors. It was agreed unanimously that RTM Landscapes be awarded the contract. Proposer Cllr Furniss, seconder Cllr Watson. As the contract sum represented a large increase on last year's budgeted amount the Clerk was instructed to negotiate a reduction if at all possible.
